**WEIGHT CLASSES:**

MALE: 39-42, 46, 50, 54, 58, 63, 69, 76, 85, 100, 115

FEMALES: 40, 43, 46, 49, 52, 56, 60, 65, 70, 80

\*Athletes in the lowest and heaviest weight classes must weigh the minimum listed, as per CAWA rules.\*

**ELIGIBILITY:**

Any athlete who meets all of the following criteria:

- born in 1998, 1997, 1996, or 1995
- need to be a current member and in good standing with SAWA
- proof of Canadian citizenship or permanent residence

Insure that all proper documentation is provided at tier 1 trials (Birth Certificate or Permanent Residence Card). Medical exemptions are allowed for tier 1 trials, for more information see selection criteria under special circumstances provided on the SAWA website.

**DRAW:**

Will be an Olympic style ladder tournament. For more information, see selection criteria posted on SAWA website. CAWA CADET age group rules will be followed.

**ENTRY FEE:**

\$20/ WRESTLER to participate in the trials.

**ADDITIONAL INFORMATION:**

- Physio will be on site, athletes need to provide own supplies
- **Participation fee of \$300 per wrestler finishing first or second in the trials is due on Sunday May 15, 2011.** Fees will be payable to SAWA.
- Wrestlers who place 1 or 2 will be required to sign the Team Sask Athlete Code of Conduct and commit to the training program as presented.
- Wrestlers invited to join tier 2 training who do not finish first or second will be expected to pay participation fee and sign Team Sask Athlete Code of Conduct and commit to training program
